

Animal Shelter: Humane Society Naples operates Southwest Florida's largest independent animal shelter and adoption program with two locations, 370 Airport Pulling Road and 2400-7 Immokalee Road. Humane Society Naples also operates a separate dog intake and behavior facility at 6551 Bur Oaks Lane. In 2020, despite limiting operations due to the pandemic, Humane Society Naples adopted 1,671 animals from its facilities and fostered 1,085 animals in homes throughout the community.

Animal Clinic: The Humane Society Naples Veterinary Clinic provides for the medical care of shelter animals and owned animals in the community, with a staff of five full-time veterinarians and more than 20 veterinary support staff. In 2020, despite limiting operations due to the pandemic, the veterinary clinic performed 1,385 spay/neuter surgeries (for shelter animals and for the public) and helped nearly 6,000 animals enjoy healthy lives.
