**Animal Shelter: Humane Society Naples operates Southwest Florida's largest independent animal shelter and adoption program with two locations, 370 Airport Pulling Road and 2400-7 Immokalee Road. Humane Society Naples also operates a separate dog intake and behavior facility at 6551 Bur Oaks Lane. Humane Society Naples adopted 1,938 animals from its facilities and fostered 1,117 animals in homes throughout the community.**

**Animal Clinic: The Humane Society Naples Veterinary Clinic provides for the medical care of shelter animals and owned animals in the community, with a staff of five full-time veterinarians and more than 20 veterinary support staff. In FY 2022-23, the veterinary clinic performed 1,953 spay/neuter surgeries (for shelter animals and for the public) and helped over 6,000 animals enjoy healthy lives.**
